*Third parties must comply with the respective selection criteria , to evidence this the participant refers to their capacity and the conditions for excluding from the procedure must not apply to them.*

*The contracting authority will require from the participant to replace the third party indicated by them if it does not meet any of the requirements under the previous sentence.*

*When an applicant or a participant in the procedure is an alliance of physical and/or natural persons, it may evidence compliance with the selection criteria with the capacity of third parties in implementation of the provisions of PPA, RAPPa and the notice.*
